B. Attempts towards isolation of algal strains into their pure cultures:

Isolated algal strains will be serially diluted, sub cultured, treated with antibiotics so as to obtain pure algal cultivars for further experimentation.

C. Classification of robust algal strains on the basis of morphology, cell size and colony characteristic

Most abundant and robust algal strains will be sub cultured possibly in their pure form to determine their morphology, cell size and colony characteristics which could aid in their classification.

D. Survival strategies of robust strains in the presence of predatory microbes:

The robust strains would be subjected to a variety of microbial contaminants and their survival strategies recorded to illustrate their mechanisms to evade predation and contamination.

Research Contribution of the PI in the above field:

Nitin Wahi been credited for the isolation of a novel microalgae strain which has been renamed as *Chlorella vulgaris* glamtr (KX363808- Gene bank accession number).

7. Significance (Not more than 100 words)

The research work could provide an insight into the unexplored algal diversity of holy kunds and ghats of Mathura region, whose water have since long been believed to possess therapeutic potential.

Survival strategies employed by algal strains in presence of predatory microbes and macrobes could be visualized. The information gathered would not only enhance our knowledge about the robust algal strains available in the area but could also unlock the mystery of algal culture maintenance in the presence of contaminants.
