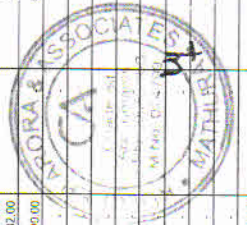

1. Basis of preparation of Financial Statements :-

2. Tangible Assets :-

- (b.) As per Accounting Standard 6, "Depreciation Accounting", the Trust is following "Written Down Value Method" for calculating depreciation on tangible assets. Depreciation on assets as on 31.03.2020 has been charged for full year, while the depreciation on assets purchased during the year has been charged for half year.
- (c.) Depreciation on fixed assets have been charged on the basis of estimated useful life of that assets.
- (d.) No revaluation on tangible assets made during the financial year 2020-2021.
- (e.) As per Accounting Standard 28, "Impairment of Assets", no impairment loss recognized during the financial year 2020-2021, because the Trust does not have any financial & operating indicator regarding impairment.

3. Investments :-
