NOTIFICATION

The Competent Authority has approved following three guidelines for faculty members of the University with immediate effect:

(1) GUIDELINES FOR PLACEMENT IN HIGHER AGP

- (a) "If the incumbent has completed 5 years of service in the grade as Assistant Professor, i.e., ₹ 15600-39000 + AGP ₹ 6000 with full DA and has fulfilled the criteria of API as per the University's rules, the benefits of next higher AGP of ₹. 7000 may be allowed"
- (b) "If the incumbent has completed 5 years of service in the grade as Assistant Professor, i.e., ₹ 15600-39000 + AGP ₹ 7000 with full DA and has fulfilled the criteria of API as per the University's rules, the benefits of next higher AGP of ₹ 8000 may be allowed".

(2) GUIDELINES FOR PROMOTION


The candidate must fulfill the following conditions for promotion from one cadre to next:

- (a) The UGC regulations in regard to experience and academic qualification as stipulated from time to time for the promotion from Assistant Professor to Associate Professor and from Associate Professor to Professor
- (b) Research publication as per the Notification No. GLAU/RO/Prof. & Assoc. Prof./Publications/5914/17 dated 16th May, 2017.
- (c) API as per GLA University norms.

(3) GUIDELINES FOR REGULARIZATION OF THE FACULTY MEMBERS

The faculty appointed as Assistant Professor/Associate Professor/Professor on ad-hoc basis will be eligible for regularization subject to fulfillment of following conditions:

- (a) He/she must have completed minimum one year of service in GLA University.
- (b) He/she must have fulfilled API requirement as notified from time to time.
- (c) He/she will have to face an interview before the duly constituted Selection Committee as per provisions of the University.
- (d) Any new requirement by Regulatory Body will have to be followed.
