Interim Consent Letter

Sub: Recognition to GLA University, Mathura, Uttar Pradesh and fresh approval to its Institute of Legal Studies & Research, GLA University, Mathura, Uttar Pradesh for imparting five year BA LL.B (Hons.) course and five year B.Com LL.B(Hons.) course with intake of one section of 60 students in each course for a period of two years from 2018-2019 and 2019-2020.

Sir.

The Standing Committee of the Legal Education Committee of the Bar Council of India at its meeting held on 19th May, 2018 considered the inspection report of Institute of Legal Studies & Research, GLA University, Mathura, Uttar Pradesh. After consideration, Committee is of the view that as per Section 7 (1) (i) of the Advocates Act, 1961 GLA University, Mathura, Uttar Pradesh be granted recognition for the purpose of conferring the degrees of law for imparting five year BA LL.B (Hons.) course and five year B.Com LL.B (Hons.) course from the academic year 2018-2019 and further fresh approval to its Institute of Legal Studies & Research, GLA University, Mathura, Uttar Pradesh for imparting five year BA LL.B (Hons.) course and five year B.Com LL.B(Hons.) course with intake of one section of 60 students in each course for a period of two years from 2018-2019 and 2019-2020.

So far, teaching staff is concerned in serial-2 Mr. Ajay who is senior advocate, he can only teach under the rule clinical subjects. No regular law subjects, hence he may be assigned only clinical subject.

University may in addition to appoint any other person qualified to teach law as per the rules within six weeks through proper selection with intimation to the Bar Council of India within same period.

The University/College is directed to also fulfill the following conditions, failure of which may lead to subsequent necessary and proper action being taken in this regard :-

- The Institution is directed to establish the Legal Aid Centre as per Clause-11, Schedule-III of Rule-11 of the Part-IV of the Legal Education Rules - 2008.
- Institution should ensure the payment of salary to teachers as per Rules 2. 22 schedule III, Part IV of BCI Rules.
- The library should be furnished as per Clause 15 of Schedule III of Legal 3. Education Rules 2008 given below :-

Minimum Library requirement: To start with, a Law Library Ashok Kumar Singh shall have a set of AIR manual, Combo offer of CD of AIR Pvt. GLA University Ltd. (containing electronic version of AIR Supremo Court and Stone, NH-2, Mathura-Delhi Road P.O.-Chaumuhan, Mathura (U.P.) INDIA

connections each) Cr. L.J. Data Base 1950-2015(four connections) AIR Privy Council Data Base 1900-1950 (four connections) AIR Mannual latest 6th Edition(1-45 Vols.) AIR Journal 2015, Cr. L.J. 2015, L.I.C. 2015, AIR Civil Cases 2015, AIR Law Lines 2015, AIR Cheque Dishonour Reports 2015, AIR Accident Claims and compensation 2015, Institution shall get electronic versions updated every year by AIR Pvt. Ltd. Central Acts and Local Acts, Criminal law journal, ECC, Company cases, Indian Bar Review, selected Judgements on Professional Ethics and Journals with the back volumes for at least ten years and also such number of text books in each subjects taught during the period according to the minimum standard ratio of ten books for each registered students. For running integrated program, text books of such other subjects are also to be kept in the similar minimum ratio.

- 4. The institution should keep in mind that minimum 10 sets of Indian Bar Review, selected judgments and professional Ethics published by Bar Council of India Trust and the AIR volumes/set must be promptly ordered for the library if not already ordered, as it is an essential requirement to run a law college which is stipulated by Bar Council of India, Legal Education Rules 2008 framed under a Parliament Act.
- 5. The institution is directed to make a minimum investment as provided below for upgrading it's library as per the following guideline:-

"Today with the increasing cost of journals, books, wifi, c-library and online facilities including I.T. facilities, the minimum investment by each university should be Rs. 10 lakhs for each year. However for any university/decmed university in rural area, the investment should be Rs. 5 Lakh and for all other affiliated colleges in the urban area it should be Rs. 2 lakhs and in rural area it should be Rs. 1 lakh."

- Teacher Student ratio shall be as per Schedule-III, Rule-11, Clause-17, Part-IV of Bar Council of India Rules.
- Institution is directed to inform the timings of the classes.
- A Centre of Legal Education must ensure that not less than three percent seats are reserved for persons with disabilities.
- 9. Centre of Legal Education shall equip itself to provide appropriate facilities in terms of the physical infrastructure, academic infrastructure and any other facilities required for the effective participation of disabled students, teachers and staff in their respective activities. For e.g. (a) ramps in public buildings and (b) Braille symbols and auditory signals in elevators or lifts.

The same shall be verified during the next inspection.

Further, the University/College must specify the timing of the college which has not been given. College should also maintain the timing which has to be minimum 5 ½ hours with half an hour break. College is directed to file an affidavit to the Bar Council of India within six weeks mentioning the timing of the classes. The relevant rules are quoted hereunder:

Rule (xxiii), Chapter I

"(rodii) "Regular Course of Study" means and includes a course which shok Kumar Singh an hour recess every day and running not less than thirty hours of GLA University

"Classes may be conducted between 8 a.m. to 7 p.m. in a Centre of Legal Education, which is not fully residential. However the Library may remain open till 10 p.m."

Further, the institution should follow the attendance rule and file reply that they are following the aforesaid rule. The next inspection team must also see whether the said rule is being followed by the university or not. The relevant Rule 12 is given below:

"12. End Semester Test: No student of any of the degree program shall be allowed to take the end semester test in a subject if the student concerned has not attended minimum of 70% of the classes held in the subject concerned as also the moot court room exercises, tutorials and practical training conducted in the subject taken together.

Provided that if a student for any exceptional reasons fail to attend 70% of the classes held in any subject, the Dean of the University or the Principal of the Centre of Legal Education, as the case may be, may allow the student to take the test if the student concerned attended at least 65% of the classes held in the subject concerned and attended 70% of classes in all the subjects taken together. The similar power shall rest with the Vice Chancellor or Director of a National Law University, or his authorized representative in the absence of the Dean of Law.

Provided further that a list of such students allowed to take the test with reasons recorded be forwarded to the Bar Council of India."

University/College should also admit students as per the below mentioned Rule:

7.Minimum marks in qualifying examination for admission: Bar Council of India may from time to time, stipulate the minimum percentage of marks not below 45% of the total marks in case of general category applicants, 42% for OBC category and 40% of the total marks in case of SC and ST applicants, to be obtained for the qualifying examination, such as +2 Examination in case of Integrated Five Years' course or Degree course in any discipline for Three years' LL.B. course, for the purpose of applying for and getting admitted into a Law Degree Program of any recognized University in either of the streams.

Nam

Provided that such a minimum qualifying marks shall not automatically entitle a person to get admission into an institution but only shall entitle the person concerned to fulfill other institutional criteria notified by the institution concerned or by the government concerned from time to time to apply for admission.

Institution should submit affidavit in compliance of the above conditions within six weeks.

The University/College shall also comply with the following Rule of the Bar Council of India (Clause (iii) and Explanation 2 of Schedule IV in Part IV of new rules of the Bar Council of India):-

"Whenever approval of affiliation is granted to the Centres of Legal Education, it shall be necessary for the Centres of Legal Education to deposit Rupees Five Lakh in shape of guarantee to fulfill all the norms of the Bar Council of India. The same shall be liable to be forfeited if norms are not compiled with and same shall carry no interest."

The letter is subject to the payment of guarantee amount as mentioned in kikumar Singh above rule.

University/College authorities are also required to apply before the Bar Council NH 2, Mathura Delhi Road India for further extension of approval six months in advance before expiry of the Mathura (UP) INDIA

period of approval of affiliation granted by the Bar Council of India. i.e. on or before 31st December, 2019.

This letter is subject to final approval/confirmation of the Legal Education Committee and General Council of the Bar Council of India.

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- 2. AND WHEREAS, the institution, GLA University, Plot No. Mathura Delhi Road, Khasara NO. 41, Street Number- NH#2, Village/Town- Ajhai, Post office-Chaumuhan, Tehsil/Taluka- Chhata, Town/City- Mathura, State- UP, District- Mathura (UP), Pin Code -281406. has by affidavit consented to come under New Regulations and has sought for two basic units in B.Ed., which require additional facilities.
- 3. AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each, subject to the institution fulfilling the following conditions, namely:-
 - (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c)additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Northern Regional Committee, with required documents by October 31, 2015.
 - (ii) The institution for additional unit will be required to submit the required documents such as, land documents, non-encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents, if available, otherwise it can also be given to the Visiting Team at the time of inspection.
 - (iii) The Regional Committee shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institution shall not be permitted to admit students for the academic year 2016-2017.
 - (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith documents, if any, together with the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- 4. Now therefore, in light of the bababove, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to GLA University, Plot No. Mathura Delhi Road, Khasara NO. 41, Street Number- NH#2, Village/Town- Ajhai, Post office-Chaumuhan, Tehsil/Taluka- Chhata, Town/City-Mathura, State- UP, District- Mathura (UP), Pin Code -281406 for conducting B.Ed. programme of two years duration with an annual intake of 100 students, for two basic units of 50 students each, from the academic session 2015-2016 subject to fulfilment of the conditions mentioned herein before 31.10.2015.
 - 5. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, State Government etc. as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building

- 2. AND WHEREAS on scrutiny/perusal of veracity of the facts & figures as per the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of visiting team report including videography, the Northern Regional Committee in its 225th meeting held on 25th February to 01st March, 2014 is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the B.Ed. programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory, etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.
- 3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to GLA University, Plot No. Mathura Delhi Road, Khasara NO. 41, Street Number- NH#2, Village/Town- Ajhai, Post office-Chaumuhan, Tehsil/Taluka- Chhata, Town/City-Mathura, State- UP, District- Mathura (UP), Pin Code -281406 for conduction of B.Ed. course of Secondary level of one year duration with an annual intake of 100 (One Hundred only) from the academic session 2014-2015 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject to fulfillment of the following conditions:-
 - The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.
 - II. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
 - III. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- 4. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.
- 5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year alongwith the statement of annual accounts duly audited by a Chartered Accountant.
- 6. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
 - I. Copy of the Application Form
 - II. Land and Building Particulars
 - III. Staff Profile
 - IV. Recognition letter
 - V. Information for having fulfilled the norms & standard and other required conditions.
- 7. In case if the land is in the name of the Society/trust, you must transfer the land within six months in the name of the institution failing which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate about the same to the respective Regional Committee along with the new land documents within the stipulated time.
- 8. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee shall withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
